## Camp Staff Scholarship Information

Starting in 2025, Tidewater Council will begin awarding scholarships to camp staff members to recognize their leadership and commitment to our Council camping program and to encourage them to pursue their education beyond high school.

Each camp staff member in good standing, who will be attending a college or post high school technical school, is eligible to participate in the program under these guidelines:

1. Scholarships are earned for each summer of COMPLETED paid service to Tidewater Council on this basis:  
1st summer = \$300      2<sup>nd</sup> summer = \$600      3<sup>rd</sup> summer = \$1000      4<sup>th</sup> summer = \$1,500
2. Once a staff member has worked five summers or more they may receive \$2,000 after each subsequent summer.
3. A staff member MUST agree to working at Pipsico the following summer.
4. A maximum of \$2,000 may be used during any one academic year. Scholarships do not rollover from school year to school year.
5. Scholarships are earned only for those summers of complete employment for a full summer program.
6. Application for scholarship as well as application/ commitment for employment for the following summers camping operation, must be made by the camp staff member by November 1 to utilize the scholarship. The scholarships are intended for camp staff members who have completed their high school education and are enrolled as a full-time undergraduate student working toward a post-secondary degree or master's degree. Evidence of enrollment must be produced upon request.
7. Scholarship funds may be used for class fees, books, or housing. Receipts must be provided.
8. **The scholarship program is in effect as long as the individual remains in the employment of Tidewater Council.** When a member ceases employment, all previously accrued credits are null and void. For example; a staff member who works only the summers of his or her sophomore and junior years of high school would not qualify to utilize any scholarship funds.
9. Camp staff members in good standing do not include:
  - A. Members dismissed from employment. Dismissal voids all previously accumulated scholarships.
  - B. Members who sign a probationary contract because of a previously sub-standard employment. A staff member, who completes a satisfactory summer while on probation, though not eligible for the scholarship amount for the summer of probation, may utilize the previous scholarship amount.
10. A former camp staff member who returns to our staff after a hiatus of a year or more will get credit for that year of service and will be eligible at the number of years served level and will not have to start over.
11. All other inquiries should be directed to the Vice President of Camping.
